

## **Rick Shalvoy**

During the summer of 1997, Rick completed his first *Row for a Cure* after losing a friend to breast cancer in 1996. An annual fundraising event (1997-2006) that involved rowing 300 miles around the outer shoreline of Long Island, New York in a 19-foot ocean rescue boat, Rick completed the entire course alone each year

with the exception of the East River segment. Nobel Laureate Dr. Harold Varmus, former Director of the National Institutes of Health, President of Memorial Sloan Kettering Cancer Center and Director of the National Cancer Institute, was Rick's rowing partner for the East River segment of the course from Wards Island to South Street Seaport.

In 1994, three years before the first *Row for a Cure* and shortly after his 24<sup>th</sup> summer working for New York State Parks as a part-time ocean lifeguard, Rick nearly lost his life when a ruptured appendix, emergency surgery and peritonitis suddenly taught him more than he ever wanted to learn about what it's like to be a patient in an intensive care unit.

During the long recovery process, Rick began to store fat tissue as his previously high level of physical activity was reduced to a primarily sedentary routine. The gradual accumulation of storage fat eventually triggered an adiposity snowball effect -- insulin resistance, higher levels of blood sugar, hunger signaling, unhealthy food cravings and more storage of adipose tissue.

After losing muscle mass and gaining fat mass for 9 months, and after being unable to pass the lifeguard test in 1995, Rick was finally able to nutritionally recover from metabolic decline, gain muscle mass and lose fat mass with the help of an obesity medicine clinician and a fitness trainer.

Upon returning to his ocean rescue job and competitive lifeboat rowing in 1996, Rick and his rowing partner enlisted the support of Dowling College administrators and crew coaches to form the first regional rowing program for high school students on the south shore of Long Island.

Rick started his professional career in 1974 by utilizing his unique combination of education and skills, veterinary technology and journalism. Working as an animal health technician, writing articles of interest to pet owners and moonlighting as an editor for clients in both the human and animal health sectors occupied most of Rick's time until he moved on from veterinary care to veterinary sales in 1982. Rick then worked for SmithKline Beckman Animal Health for several years before making the transition to human healthcare when he was recruited for the position of New York Regional Manager for SmithKline Diagnostics, a position from which he was promoted to Director of Patient Education Programs in 1992.

While serving as the Medical Marketing Association's Northeast Chapter President and directing patient education programs for SmithKline Diagnostics, Rick and his colleagues at Astra Merck and Abbott Laboratories worked collaboratively with the American Digestive Health Foundation to sponsor and launch the *Digestive Health Initiative*, a national consumer health education campaign that was overseen by the American Gastroenterological Association.

As Founder and President of Consumer Health Education Programs, Rick is devoted to educating consumers about free and low-cost options for screening and diagnostic testing with a special focus on helping patients who are living with obesity and obesity-associated metabolic disorders. Every free or low-cost testing referral is accompanied by resources to help patients find qualified healthcare providers who treat patients with dignity, compassion and the highest standards of personalized care.
